**ONE HORSE PER FORM. Make copies for additional horses.**

**A. Horse Recording - Use this section to record a new horse for the purposes of participating in:**

1. USEF Awards including Farnam®/Platform™ USEF Horse of the Year Program.
2. All FEI Competitions (Passports).
3. USEF/USDF Qualifying and Championship Classes and USEF National Championships for Dressage (see DR127).

The horse/pony must be exhibited under the exact name and owner as recorded with USEF. The recording becomes effective on the date the required materials and fees are received by the USEF office (Exception: GR1110). The horse/pony must be recorded on or before the start date of the competition for points to count. The owner of the horse/pony must be a Senior Active, Junior Active, or Life member for points to count OR if the horse is recorded as owned by a farm, partnership, corporation or syndicate, that entity must record its name as a "farm" registration and at least one owner must be a Senior Active, Junior Active, or Life member of the Federation. Points will not be credited retroactively (see GR1110). This form should not be used to report a transfer of ownership, lease or name change of a horse with an active recording. **If the horse/pony is being renewed under a new ownership, you must submit a bill of sale.**

Choose either Life or Annual Horse Recording from below:

Lifetime Recording of the Horse/Pony (Required for Passports). To qualify for age discount, proof of age must be provided (i.e. registration papers, coggins).

- a. \$35 from birth to December 31st of year foaled.
- b. \$85 for horses one year of age (from January 1st to December 31st of the first year after foaling).
- c. \$160 for horses two years of age (from January 1st to December 31st of the second year after foaling).
- d. \$200 for horses three years of age or older.

**C. NEW USHJA Registration**

Effective December 1, 2008 all horses competing in USEF licensed non-breed restricted competitions with hunter, jumper, and/or hunter seat equitation classes (except for leadline, exhibitions, games and races, classes for 4-H members, walk -trot and academy classes, Opportunity classes) must have a USHJA Registration Number. USEF Life Recorded horses recorded before **November 30, 2008** are exempt from the requirement to have a USHJA Registration Number and their USEF Recording number will serve as a USHJA Registration number. Any horse with a USEF Life Recording prior to November 30, 2008 will be automatically enrolled in the USHJA Registry. .... **One time fee of \$30**
